Waiver, Release of Liability & Participation Agreement

This document serves as a waiver of legal rights and an agreement to release and hold harmless **The Nature Nest Preschool, LLC**, its owners, directors, officers, employees, volunteers, agents, representatives, activity leaders, and sponsors (hereinafter referred to as “The Nature Nest” or “Released Parties”) from any and all claims related to death, disability, personal injury, property damage, or property loss that may occur to me and/or my minor child(ren) while on the premises located at 166 Albany Turnpike, Canton, CT 06219, Suite 3 (“Property”), or while participating in any Nature Nest activities.

This Agreement is made in consideration of The Nature Nest Preschool, LLC permitting my child(ren) and me (hereinafter referred to as “Participants”) to voluntarily take part in preschool drop-off classes, programs, and related activities (hereinafter “Activities”). These Activities may include, but are not limited to, the use of art and sensory materials such as paint, markers, beads, scissors, glue, clay, wood, tools, small loose parts, fabrics, water, food products, and other materials that may present inherent risks, including choking hazards. Activities may also take place outdoors and may involve exposure to water, snow, ice, rain, and other weather conditions with potential hazards. I understand that participation requires appropriate supervision and that I am responsible for ensuring my child’s readiness and understanding of all associated risks.

Assumption of Risk

I understand and acknowledge that participation in The Nature Nest Preschool, LLC activities involves inherent risks, including but not limited to slips, falls, cuts, allergic reactions, exposure to weather conditions, contact with other children, and injuries related to the use of play, sensory, and art materials. I knowingly and voluntarily assume all such risks, both known and unknown, even if arising from the negligence of the Released Parties or others. I accept full responsibility for my child’s participation and agree that The Nature Nest Preschool, LLC is not responsible for any injuries, losses, or damages that may occur as a result of participation in these activities.

Illness and Communicable Disease Release

I acknowledge that participation in programs and activities at The Nature Nest Preschool, LLC involves potential exposure to illnesses, including but not limited to COVID-19, influenza, and other communicable diseases. I voluntarily assume all risks related to such exposure and agree to release and hold harmless The Nature Nest Preschool, LLC and its owners, employees, agents, and representatives from any claims, damages, or liabilities arising from illness, infection, or related complications resulting from participation in drop-off classes, play, or any activities associated with The Nature Nest Preschool. I understand that while reasonable precautions may be taken, the school cannot guarantee that exposure will not occur.



General Release and Property Damage Responsibility

I agree to release and hold harmless The Nature Nest Preschool, LLC, its owners, employees, agents, and representatives from any and all liability, claims, demands, or causes of action arising from my child's participation in any programs, classes, play, or activities associated with The Nature Nest Preschool, LLC, except in cases of gross negligence or willful misconduct by the school.

In the event that any damage to equipment, materials, or facilities occurs as a result of my actions, my child's actions, or the actions of any family member or agent, whether due to willful conduct, negligence, or recklessness, I acknowledge and agree to be financially responsible for any and all costs, fees, and expenses associated with such damage, including repair or replacement.

Medical Emergency Authorization

In the event of a medical emergency involving my child while participating in any program or activity at The Nature Nest Preschool, LLC, I authorize The Nature Nest Preschool, LLC and its representatives to seek emergency medical treatment for my child if I cannot be reached in a timely manner. This may include, but is not limited to, contacting emergency medical services and transporting my child to the nearest hospital or medical facility.

I understand that every reasonable effort will be made to contact me or the emergency contacts listed prior to treatment when possible. I accept full financial responsibility for any medical expenses incurred as a result of such treatment and agree to release and hold harmless The Nature Nest Preschool, LLC from any liability related to the provision of emergency medical care.

Payment and Fee Responsibility

I acknowledge that as the parent or legal guardian, I am responsible for payment of all programs, class, and participation fees associated with my child's enrollment and attendance at The Nature Nest Preschool, LLC. I further understand and agree that late pick-up will result in a flat fee of \$50, and that any additional fees incurred due to policy violations, late payments, or special services are my financial responsibility. Failure to remit payment for required fees may result in suspension or termination of participation in programs or activities.

Legal Compliance and Good Faith

This Agreement is intended to comply with all applicable laws and regulations of the State of Connecticut and is executed in good faith for the purpose of ensuring the safety, transparency, and mutual understanding between The Nature Nest Preschool, LLC and participating families. This document is meant to encompass all risks, responsibilities, and expectations associated with participation in programs and activities at The Nature Nest Preschool, LLC, whether such risks or responsibilities are specifically listed herein.
